CIVIL SOCIETY IN UKRAINE: A UNIQUE ROLE BEYOND THE WATCHDOG



- Ukrainian CSOs go beyond the watchdog role – they are implementers, not just advocates
- They deliver humanitarian aid, rebuild infrastructure, support the army, and offer public services
- Over **50%** are involved in social service provision, often without state funding or formal recognition
- ISAR Ednannia contributes to systemic reform, integrating CSOs into the social service system



KEY CHALLENGES FOR CIVIL SOCIETY 2025



War and security risks

- Many CSOs operate on the frontline or in occupied areas — often the only ones present where the state cannot reach

Newcomers without experience

- Many post-2022 CSOs lack capacity. The sector needs to integrate them into the broader ecosystem for sustainable recovery

Limited cooperation with central government

- Engagement is often superficial or tokenistic, with weak access to decision-making

Under-recognition in social services

- Though over half provide social support, only 12% are officially registered as service providers

AFTER THE USAID CUTS – A SECTOR AT RISK



- Over \$3B in aid suspended, affecting civil society, governance, media, and recovery programs
- Many CSOs lost core funding, forcing them to scale down or operate without salaries, logistics, or premises
- Support for independent media and local governance initiatives was sharply reduced
- Critical infrastructure and development programs—including community resilience, health system reform, and local capacity-building—were halted mid-course
- Long-term civil society development efforts have been disrupted, with training, advocacy, and institutional growth paused or cancelled

EU INTEGRATION – UNLOCKING CIVIL SOCIETY POTENTIAL



Ukraine's CSOs are eager to support reforms and EU accession, but many still face capacity gaps in policy engagement, advocacy and fundraising:

- Barriers include: complex procedures, limited awareness of EU tools, and no direct access to EU funds
- Media requires renewed support

What's needed:

- Structured support for CSO capacity-building
- Direct funding mechanisms for local CSOs
- Stronger inclusion in EU-aligned reform and recovery planning

CIVIL SOCIETY STRENGTHS



- **Unity:** CSOs form networks to mobilize resources and deliver aid, supporting veterans and recovery
- **Resilience:** Operate independently, adapting to crises despite donor exits like USAID
- **Trust:** High public and international confidence due to transparency and alignment with shared values
- **Expertise:** Skilled professionals drive evidence-based advocacy in human rights, education, and health
- **Volunteering:** Volunteers bolster CS efforts, delivering critical services and reforms

CIVIL SOCIETY WEAKNESSES



- **Donor dependency:** Overreliance on foreign funding; weak self-financing limits sustainability
- **Fragmentation:** Competitive culture hinders structured collaboration among CSOs
- **Short-term focus:** Tactical actions overshadow long-term strategic planning
- **Brain drain:** Migration and low youth engagement reduce innovation

PESTEL FACTORS

Political: EU integration demands new standards; weak CSO-government dialogue

Economic: Focus on basic needs limits strategic growth; donor dependency risks instability

Sociological: High social cohesion but war fatigue and migration strain resources

Technological: AI boosts efficiency but cybersecurity and digital divide pose challenges

Ecological: War-related contamination poses significant challenges

Legal: Administrative pressures and unclear lobbying laws restrict CSO advocacy



FORESIGHT INSIGHTS: **KEY SCENARIOS**

1. **Autopilot:** Stable but vulnerable conflict, societal polarisation, growing VPK.
2. **Strength Test:** Escalating combat, stable but tired support, deep societal depression.
3. **Still Alive:** Stable combat, reduced US support, European aid persists.
4. **Cautiously Optimistic:** Declining combat, stable support, gradual recovery.
5. **Early Recovery:** Reduced combat, conditional peace, infrastructure rebuilding.
6. **Geopolitical Solitude:** No external support, economic collapse, authoritarian shift.

Key Uncertainties: Intensity of combat (decline or increase); EU/world support (stable/growing or decreasing/ending).



UKRAINE'S DEMOCRATIC DOCTRINE: SAFEGUARDING GLOBAL FREEDOM



As global democracy faces rising authoritarianism, disinformation, and instability, Ukraine stands not only as a battlefield for sovereignty but as the frontline defender of democratic values.

The Doctrine of Ukrainian Democracy presents a strategic vision positioning Ukraine as a pillar of global democratic resilience, emphasizing:

- Ukraine's fight against Russia is a civilizational struggle—testing whether democracy can endure amidst war, disruption, and authoritarian pressure.
- Ukraine's accession to the EU is key not only for national reform, but also for the future cohesion and credibility of Europe itself.
- Ukraine offers a model for resisting disinformation, fostering post-war renewal, and strengthening social cohesion under extreme conditions.
- Victory and reform in Ukraine are vital for the survival of the global democratic order.

- Promote social cohesion and democratic value
- Serve as a watchdog and a bridge between citizens and state institutions

- Sustain support for Ukraine as a democracy frontier
- Invest in recovery and EU integration
- Collaborate with Ukraine to counter disinformation, defend human rights, and shape a more resilient global order
